Grand Council Royal and Select Masters of Alabama Notes to Financial Statements For the period ended December 31, 2010

Note 1 - Summary of Significant Accounting Policies

A. Basis of Accounting

The Grand Council's policy is to prepare its financial statements on the cash basis of accounting. Under this method certain revenue and the related assets are recognized when received rather that when earned and certain expenses are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying financial statements do not purport to present the current financial position.

B. Inventories

Inventories are carried at the lower of cost determined by the first-in, first-out method, of market.

C. Property and Equipment

Property and equipment are recorded at cost and were depreciated over the estimated useful lives of the related assets. Depreciation was computed on the straight-line method for financial reporting purposes.

Note 2 - Tax Status

The Grand Council is exempt from federal income tax under Internal Revenue Code Section 501° , and from state income tax under Alabama Code Section 40-18-32. An information return is filed each year on IRS form 990.

Note 3 - Restricted Assets

A Triennial Reserve account is established as a reserve to cover expenses for specific officers to attend the Triennial Meeting. During the year there was an increase in the balance of this reserve account to \$1,800.00


